Definition


The HMSR is a new generation of highly insulated Integrated Current Sensor from LEM.

This product family provides a robust, compact and very accurate solution for measuring DC and AC currents in all highly demanding, switching power applications for commercial, industrial. HMSR is a micro core based open loop sensor with a reinforced insulation and overcurrent detections (user configurable and factory set). These features make the device suitable for high voltage applications requiring high precision and strong immunity against external field.

The primary conductor (pins 1 and 8) has very low electrical resistance and dedicated pads designed to withstand high surge currents such as lightning strikes.

HMSR is measuring the magnetic field generated by the current flowing in the copper primary path of the device. By using a micro magnetic core, HMSR is immune to the external fields, making the device well suited for power electronic applications with high levels of disturbance.

The reinforced isolation between primary (pins 1 and 8) and secondary (pins 9 to 15) offers the HMSR, as a small, cost effective solution to measure high side current compared to resistive isolated solutions.




Figure 1: Typical value on HMSR 20-SMS/SP11 (40 parts)

Measuring range vs ambient temperature



Definition of typical, minimum and maximum values

Minimum and maximum values for specified limiting and safety conditions have to be understood as such as well as values shown in “typical” graphs.

On the other hand, measured values are part of a statistical distribution that can be specified by an interval with upper and lower limits and a probability for measured values to lie within this interval.

Unless otherwise stated (e.g. “100 % tested”), the LEM definition for such intervals designated with “min” and “max” is that the probability for values of samples to lie in this interval is 99.73 %.

For a normal (Gaussian) distribution, this corresponds to an interval between -3 sigma and +3 sigma. If “typical” values are not obviously mean or average values, those values are defined to delimit intervals with a probability of 68.27 %, corresponding to an interval between -sigma and +sigma for a normal distribution.

Typical, maximal and minimal values are determined during the initial characterization of the product.





Block diagram



Total error referred to primary

The total error ϵ_{tot} is the error at $\pm I_{PN}$, relative to the rated value I_{PN} .

It includes all errors mentioned above

- the electrical offset I_{OE}
- the magnetic offset I_{OM}
- the sensitivity error ϵ_s
- the linearity error ϵ_L (to I_{PN}).




Figure 6: Total error ϵ_{tot}

Electrical offset referred to primary




Figure 7: Current cycle used to measure magnetic and electrical offset (transducer supplied)

Using the current cycle shown in figure 7, the electrical offset current I_{OE} is the residual output referred to primary when the input current is zero.

$$I_{OE} = \frac{I_{P(3)} + I_{P(5)}}{2}$$

Magnetic offset referred to primary

The magnetic offset current I_{OM} is the consequence of a current on the primary side ("memory effect" of the transducer's ferro-magnetic core). It is measured using the following primary current cycle. I_{OM} depends on the current value $I_P \geq I_{PN}$. K_{OL} : Overload factor

Sensitivity and linearity

To measure sensitivity and linearity, the primary current (DC) is cycled from 0 to I_P , then to $-I_P$ and back to 0 (equally spaced $I_{PN}/10$ steps). The sensitivity S is defined as the slope of the linear regression line for a cycle between $\pm I_{PN}$.

The linearity error ϵ_L is the maximum positive or negative difference between the measured points and the linear regression line, expressed in % of I_{PN} .

Delay times

The delay time t_{D10} @ 10% and the delay time t_{D90} @ 90% with respect to the primary are shown in the next figure.

Both slightly depend on the primary current di/dt . They are measured at nominal current.




Figure 8: t_{D10} (delay time @ 10%) and t_{D90} (delay time @ 90%).

PCB footprint (in mm)



Soldering on PCB




- Rework not recommended.


