



Definition of typical, minimum and maximum values

On the other hand, measured values are part of a statistical distribution that can be specified by an interval with upper and lower limits and a probability for measured values to lie within this interval.


Unless otherwise stated (e.g. "100 % tested"), the LEM definition for such intervals designated with "min" and "max" is that the probability for values of samples to lie in this interval is 99.73 %.

For a normal (Gaussian) distribution, this corresponds to an interval between -3 sigma and +3 sigma. If "typical" values are not obviously mean or average values, those values are defined to delimit intervals with a probability of 68.27 %, corresponding to an interval between -sigma and +sigma for a normal distribution.

Typical, maximal and minimal values are determined during the initial characterization of a product.



Typical performance characteristics $I_{\rm P\,N}$ = 8 A







Figure 1: Linearity error

Figure 2: Frequency response






Figure 3: Step response

Figure 4: dv/dt





Figure 5: Output noise



Typical performance characteristics $I_{\rm P\,N}$ = 15 A






Figure 6: Linearity error




Figure 7: Frequency response




Figure 8: Step response





Figure 10: Output noise

Typical performance characteristics $I_{\rm P\,N}$ = 25 A







Figure 11: Linearity error

Figure 12: Frequency response






Figure 13: Step response

Figure 14: dv/dt





Figure 15: Output noise



Maximum continuous DC primary current






Figure 16: $I_{\rm P}$ vs $T_{\rm A}$ for HO series





Figure 18: $I_{\rm P}$ vs $T_{\rm A}$ for HO series





 = 25 °C $I_{\rm P}$ = 110 ($U_{\rm ref}$ = 0.5 ... 0.776 V) $I_{\rm P}$ = -54.35 × $U_{\rm ref}$ + 152.17 ($U_{\rm ref}$ = 0.776 ... 1.65 V)

Lower limit:
$$I_P = -54.35 \times U_{ref} + 27.17 (U_{ref} = 0.5 ... 1.65 \text{ V})$$

Example with $U_{\rm ref}$ = 0.5 V:

- The 8 A version has a measuring range from 0 A to 40 A
- The 15 A version has a measuring range from 0 A to 75 A
- The 25 A version has a measuring range from 0 A to 80 A at T_A = 105 °C

Example with U_{ref} = 1.5 V:

- The 8 A version has a measuring range from −17.4 A to + 22.6 A
- The 15 A version has a measuring range from -32.6 A to + 42.4 A
- The 25 A version has a measuring range from -54.4 A to + 70.6 A



Terms and definitions

Ampere-turns and amperes

The transducer is sensitive to the primary current linkage $\Theta_{\rm P}$ (also called ampere-turns).

$$\Theta_{\mathsf{P}} = N_{\mathsf{P}} \cdot I_{\mathsf{P}}$$

Where $N_{\rm p}$ is the number of primary turn (depending on the connection of the primary jumpers).

Caution: As most applications will use the transducer with only one single primary turn ($N_{\rm p}$ = 1), much of this datasheet is written in terms of primary current instead of current linkages. However, the ampere-turns (A) unit is used to emphasis that current linkages are intended and applicable.

Simplified transducer model

The static model of the transducer with voltage output at temperature $T_{\rm A}$ is:

$$U_{\text{out}} = S \cdot \Theta_{\text{P}} (1 + \varepsilon)$$

In which (referred to primary):

$$\varepsilon \cdot \Theta_{\mathsf{P}} = U_{\mathsf{O}\,\mathsf{E}} + U_{\mathsf{O}\,T} + \varepsilon_{\mathsf{S}} \cdot \Theta_{\mathsf{P}} + \varepsilon_{\mathsf{S}\,T} \cdot \Theta_{\mathsf{P}} + \varepsilon_{\mathsf{L}}(\Theta_{\mathsf{P}\,\mathsf{max}}) \cdot \Theta_{\mathsf{P}\,\mathsf{max}} + I_{\mathsf{O}\,\mathsf{M}}$$

This model is valid for primary ampere-turns $\Theta_{\rm p}$ between $-\Theta_{\rm p\,max}$ and $+\Theta_{\rm p\,max}$ only.

This is the absolute maximum error. As all errors are independent, a more realistic way to calculate the error would be to use the following formula:

$$\varepsilon = \sqrt{\sum_{i=1}^{N} \varepsilon_i^2}$$

Total error referred to primary

The total error $\varepsilon_{\rm tot}$ is the error at $\pm I_{\rm P\,N}$, relative to the rated value $I_{\rm P\,N}$.

It includes all errors mentioned above:

- the electrical offset U_{OF}
- the magnetic offset I_{OM}
- the sensitivity error ε_s
- the linearity error ε_{l} (to I_{PN}).




Figure 19: Total error ε_{tot}

Electrical offset referred to primary

Using the current cycle shown in figure 19, the electrical offset current $I_{\rm O\,E}$ is the residual output referred to primary when the input current is zero.

$$I_{\text{OE}} = \frac{I_{\text{P(3)}} + I_{\text{P(5)}}}{2}$$

The temperature variation $I_{\rm O\ T}$ of the electrical offset current $I_{\rm O\ E}$ is the variation of the electrical offset from 25 °C to the considered temperature.

$$I_{\text{O }T}(T) = I_{\text{O E}}(T) - I_{\text{O E}}(25 \text{ }^{\circ}\text{C})$$

Magnetic offset referred to primary

The magnetic offset current I_{OM} is the consequence of a current on the primary side ("memory effect" of the transducer's ferromagnetic parts). It is measured using the following primary current cycle. I_{OM} depends on the current value $I_{\text{P}} \geq I_{\text{PN}}$. K_{OL} : Overload factor




Figure 20: Current cycle used to measure magnetic and electrical offset (transducer supplied)

$$I_{OM} = \frac{I_{P(3)} - I_{P(5)}}{2}$$



Performance parameters definition

Sensitivity and linearity

To measure sensitivity and linearity, the primary current (DC) is cycled from 0 to $I_{\rm p}$, then to $-I_{\rm p}$ and back to 0 (equally spaced $I_{\rm p}/10$ steps). The sensitivity S is defined as the slope of the linear regression line for a cycle between $\pm I_{\rm p\,N}$.

The linearity error $\varepsilon_{\rm L}$ is the maximum positive or negative difference between the measured points and the linear regression line, expressed in % of $I_{\rm PN}$.

Delay times

The delay time $t_{\rm D\,10}$ @ 10 % and the delay time $t_{\rm D\,90}$ @ 90 % with respect to the primary are shown in the next figure. Both slightly depend on the primary current ${\rm d}i/{\rm d}t$. They are measured at nominal current.




Figure 21 :Delay time $t_{D.90}$ @ 90 and delay time $t_{D.10}$ @10

The primary resistance is 0.36 m Ω per conductor at 25 $^{\circ}\text{C}.$






PCB Footprint
