


# Current Transducer LT 100-S/SP37

For the electronic measurement of currents: DC, AC, pulsed..., with galvanic separation between the primary circuit and the secondary circuit.


Caution, risk of electrical shock

This transducer is a build-in device, whose conducting parts must be inaccessible after installation. A protective housing or additional shield could be used.

Main supply must be able to be disconnected.

### Mechanical characteristics

- General tolerance  $\pm 0.5$  mm
- Transducer fastening 4 holes  $\varnothing 4.3$  mm  
4 M4 steel screws
- Recommended fastening torque 3.2 N·m
- Primary through-hole  $\varnothing 15$  mm
- Connection of secondary 3 Faston 6.3  $\times$  0.8 mm

### Remarks

- $I_s$  is positive when  $I_p$  flows in the direction of the arrow.
- Temperature of the primary conductor should not exceed 100 °C.
- Dynamic performances ( $di/dt$  and delay time) are best with a single bar completely filling the primary hole.
- To measure nominal currents of less than 100 A, the optimum accuracy is obtained by having several primary turns (nominal current  $\times$  number of turns = 100 At).
- Installation of the transducer must be done unless otherwise specified on the datasheet, according to LEM Transducer Generic Mounting Rules. Please refer to LEM document N°ANE120504 available on our Web site: <https://www.lem.com/en/file/3137/download/>.
